<sup>&</sup>lt;sup>2</sup> This course will have three components: (a) Moot Court - 30 marks: 3 moot courts with 10 marks each (5 marks for written submissions & 5 for oral advocay). (b) Observance of Trial in two cases, one Civil and One Criminal - 30 marks: Students may be required to attend two trials in the course of the last two or three years of LL.B. studies. They will maintain a record and enter the various steps observed during their attendance on different days in the court assignment. This scheme will carry 30 marks. (c) Interviewing techniques and Pre-trial preparations and Internship diary - 30 marks: Each student will observe two interviewing sessions of clients at the Lawyer's Office/Legal Aid Office and record the proceedings in a diary, which will carry 15 marks. Each student will further observe the preparation of documents and court papers by the Advocate and the procedure for the filing of the suit/petition. This will be recorded in the diary, which will carry 15 marks. (d) The fourth component of the paper will be Viva Voce examination on all the above three aspects - 10 marks.
