All First Year Students of SVVV, Indore who wish to avail the University Bus Facility are hereby informed to deposit the bus fee (in single installment) for the Academic Session 2025-26 in the Accounts Office on or before 12<sup>th</sup> September 2025 (Friday).

- Bus Fee (per year):
  - o Indore: ₹16,000
  - o Ujjain, Dewas, Sanwer, Depalpur, Chandravati Ganj, Pithampur, and Mhow: ₹20,000

Students who fail to deposit the bus fee by the due date will **not be permitted** to use the bus facility. After depositing the bus fee, students are required to collect their **Bus Pass** by presenting the bus fee slip.

Shri Vaishnav Group Hostel students (exempted from transportation fees) are mandatory to collect their bus pass by showing the Hostel Admission Slip to the concerned staff at Mokshagundam Visvesvaraya Block (Civil Block), Room No. 101.

#### **Instructions:**

- 1. Students must not board the University Bus without depositing the prescribed fee.
- 2. It is mandatory to carry the **Bus Pass** while availing the bus facility.

3. Disciplinary action and a fine will be imposed on any student found using the bus facility without paying the bus fee.

All the students of SVVV Indore who wish to avail the bus facility are hereby informed to deposit bus fee (in single installment) for the Academic Session 2025-26 in the Accounts Office before 12<sup>th</sup> August 2025 (Tuesday). The bus fee for Indore is INR 16,000 per year and for Ujjain, Dewas, Sanwer, Depalpur and Chandravati Ganj INR 20,000 per year. Students who fail to deposit the bus fee by the due date will not be allowed to use the bus facility.

Disciplinary action and fine will be initiated against a student found availing bus facility without depositing the bus fee.

All the II<sup>nd</sup>, III<sup>rd</sup>, and IV<sup>th</sup> Year Students are instructed not to board the University bus without depositing the bus fees, as for them the last date for bus fees deposition is 12<sup>st</sup> August 2025.

All the Ist Year Students are instructed not to board the University bus without depositing the bus fees, as for them the last date for bus fees deposition is 12<sup>st</sup> September 2025.

### Office Order

The Bus Pass is an important component for the campus security system and is, therefore, non-transferable. It is mandatory for each student to keep the bus safe for everybody by displaying his/her Bus Pass visibly on his/her person while traveling in the SVVV buses. Some students have been found in the buses without their Bus Pass.

In view of this, all the students are herewith advised to carry Bus Pass during their travel in SVVV buses. Tampering with the Bus Pass, using another student's Bus Pass, or allowing other students to use one's Bus Pass will be treated as an act of indiscipline. The lapses in this regard shall be viewed seriously. All students are advised to comply with the instructions strictly. Those students who do not have Bus Pass should contact **Dr. Upendra Gupta**, Coordinator – Transport Committee on **Cell no 9977196921** for processing of their Bus Pass.

All those who have received the Bus Pass, but have lost or damaged the same should deposit the fine in **Accounts Section** and report to **Civil Block at Room No. 101** for getting Duplicate Bus Pass on showing the fine receipt issued by *Accounts Section*. If a student is found to avail bus facility without depositing the Bus Fee, or using bus facilities in unauthorized manner, the fine shall be charged as mentioned below:

S.No.	Particulars	Fine/Action
1.	Use of Bus Facility without depositing Fee (First Time)	Rs. 1000/-
2.	Use of Bus Facility without depositing Fee (Second Time)	Appropriate Disciplinary action
3.	Duplicate Bus Pass Charges	Rs. 250/-
4.	Using Tampered Bus Pass or using Invalid Bus Pass or allowing other student to use one's Bus Pass or using another student's bus pass.	Appropriate Disciplinary action
