All the UG/PG/ Ph.D students of *Fifth Year (IX Sem)/ Fourth Year (VII Sem) / Third Year (V Sem) / Second Year (III Sem)* of the A.Y. 2025-26 are hereby informed that their *classes shall commenced from July 21, 2025 (Monday)* except *B.Tech. VII Semester, BCA V Semester, and MCA III Semester regular classes will commence from 4th August 2025(Monday)*. They should deposit **semester fee till July 24, 2025 (Thursday)** through SVVV-ERP portal via respective student Login only (through Desktop), failing which they shall not be treated as regular students of the class and therefore they will not be allowed to attend the regular classes (theory, practical and tutorial). It may be noted that it is mandatory to deposit the fee for registration as a regular student in the next semester of the program.

The Students who are unable to deposit the semester fee will not be allowed to participate in the academic activities of the current session. Those students having **less than 75% attendance** shall not be allowed to appear in the End Semester Examination.
