Stimulants: Amphetamines, Cocaine, Nicotine **Depressants:** Alcohol, Barbiturates- Nembutal, Seconal, Phenobarbital Benzodiazepines —Diazepam, Alprazolam, Flunitrazepam **Narcotics:** Opium, morphine, heroin Hallucinogens: Cannabis & derivatives (marijuana, hashish, hash oil).

Social Efforts for Prevention of Drug Abuse:

Role of Family and Social Institutions (Parent child relationship, Family support, Supervision, Shaping values, Active Scrutiny; School Counselling, Teacher as role-model. ParentTeacher-Health Professional Coordination, Random testing on students.

Media (Restraint on advertisements of drugs, advertisements on bad effects of drugs, Publicity and media, Campaigns against drug abuse, Educational and awareness program

Legislation: NDPs act, Statutory warnings, Policing of Borders, Checking Supply/Smuggling of Drugs, Strict enforcement of laws, Time bound trials.
