1. Meritorious Students(First Year Students Only)

 - b. 85% - 95% marks in 10+2/Graduation
 - c. 75% - 85% marks in 10+2/Graduation
 - d. 65% - 75% marks in 10+2/Graduation
 - e. (Entrance Exam Based):CAT: 75% and above Percentile MAT/XAT/ATMA/C-MAT: 90% and above Percentile (First Year Students Only)
2. Girl Students (First Year Students Only)
3. Siblings (First Year Students Only)
4. Wards of Alumni (First Year Students Only)
5. Physically Challenged Students (40% physical disability) (First Year Onward)
6. Scholarship to Employees and their Wards (First Year Onward)
7. Scholarship to Students of Institutions Sponsored by Shri Vaishnav Group of Trusts (First Year Onward)
8. Children of Deceased/Retired Defence Personnel/Central Armed Police Force (First Year Onward)
9. Merit Scholarships: CGPA 8.5 and above (Second Year Onward)
10. Merit-cum-Means Scholarships: CGPA 7.5 and above Parental income: Rs. 3,00,000/- or less per annum (Second Year Onward)

Application Procedure:

Eligible students must fill and submit the scholarship form via the ERP portal using their ERP credentials.

Academic → Student Section Transaction → Scholarship Application (Student Login)

Last Date to Submit Applications is 15th December 2024. After this date, no scholarship applications will be entertained. Students are required to **keep a copy of the Document Report** after submitting the application form for reference.

Document Submission:

1. Students must upload all required documents (listed in Annexure I) in PDF format.
2. Affidavit on Rs. 100 Stamp Paper (Annexure II) must be submitted, stating that the student is not receiving any other scholarship from a different source.(After Declaration of Scholarship List)

Point to be Noted:
